A RESOLUTION AMENDING RESOLUTION 09-26-2017A RULES AND REGULATIONS FOR THE PLAINS COMMUNITY PARK

WHEREAS, a board of township trustees pursuant to *Ohio Revised Code §505.261* may acquire suitable lands and materials, including landscape planting and other site improvement materials and playground, athletic, and recreational equipment and apparatus, to establish a township park pursuant to *Ohio Revised Code §505.26*; and

WHEREAS, a board of township trustees pursuant to *Ohio Revised Code §511.32(F)* may protect and preserve to public uses for park purposes all of such property and improvements, and, to that end, adopt bylaws, rules, and regulations for the government and control of any such park, square, or grounds and the driveways and walks therein, and protect them and the trees, shrubbery, plants, and improvements from misuse, injury, or destruction, and provide for the enforcement of such rules and regulations by fines and penalties; and

WHEREAS, the Athens Township Board of Trustees in the best interest of the residents of the Township desires to amend park rules and regulations contained in *Resolution 09-26-2017A* governing conduct in and use of township parks and facilities; to provide for a safe and enjoyable environment for all residents and users of township park grounds and facilities; identify entities and individuals authorized to enforce rules and regulations and establish fines and penalties for violations thereof.

NOW THEREFORE BE IT RESOLVED by the Board of Trustees of Athens Township, Athens County, Ohio as follows:


SECTION 1: The Athens Township Board of Trustees hereby amends *Resolution 09-26-2017A, The Plains Community Park Rules and Regulations* in accordance with "EXHIBIT A" attached hereto and incorporated herein by reference.

SECTION 2: It is found and determined that all formal actions of the Board of Trustees of Athens Township, Athens County, Ohio concerning and relating to the formation and adoption of this Resolution were discussed and voted upon by the Board in open public meetings and in compliance with all legal requirements, including *Ohio Revised Code §121.22*.
