DEFINITIONS:

- Lot: Land occupied or to be occupied by a building and its accessory buildings together with such open spaces as are required under this resolution and having its principal frontage upon a street or officially approved place.
- **Structure:** Anything constructed or erected, the use of which required a <u>permanent location on the ground</u> or attached to something having a permanent location on the ground, including advertising signs, billboards, pergolas, farmers roadside stands, TV dishes and/or satellite dishes (disc), but not including fences or walls used as fences.
- Accessory building: <u>A subordinate structure</u> or building, detached from, but located on the same lot, as the principal structure or building, the use of which is incidental and accessory to that of the principal structure, building, or use. Accessory structures include, but are not limited to detached residential garages, storage sheds and barns, attached carports and picnic shelters.
- Use: The purpose or activity for which land or buildings are arranged, designed, or for which lands or buildings are occupied or maintained.
- Accessory use: <u>A</u> use or <u>structure subordinate to the principal use</u> of a building or to the principal use of land and which is located on the same lot serving a purpose customarily incidental to the use of the principal building or land use.
