 - If the Trustees chose to do so they may review the bids until the following meeting, December 10th at 5:30 pm when they shall award the contract.
- The estimated time frame for this project to begin is ASAP and completed by 2/1/2025.

- Considering the project is inside the Athens City Limits, Contractor must follow all "Athens City"
 licensure requirements.
